What is Publish OA?

- A feasibility study for a national editorial management system and platform for books and journals that publishers want to publish Diamond Open Access
- Publishers, readers, authors and funders are the stakeholders
- Increased knowledge of the needs of publishers and authors to move towards Diamond OA publishing and a practical plan to achieve it







What will we do?

- Feasibility report
- Digital directory of Irish publishers
- Landscape report of Irish publishing and of the requirements of publishers to transition to Diamond OA
- Publisher engagement, mentoring and a support programme
- National set of OA publishing principles and standards for publishers
- National set of OA publishing principles and standards for authors

The Federation of Finnish Learned Societies


Federation of Finnish Learned Societies

- Established 1899: national co-operative body for learned societies in Finland
- Funded by the state 4 350 000 euros + some own income (360 000 e)
- Directs state publishing and conference subsidies (about 2 000 000 e)
- Staff: about 40 +/- 4 persons (in projects)
- 295 member societies + 4 science academies
- Law on Federation of Finnish Learned Societies mentions three basic tasks:
 - Advance co-operation between learned societies
 - Advance scholarly communication and learned publishing
 - Promote research based information in society
- Nowadays also running Publication Forum and coordinating open Science on national level

Publishing services

- Bookstore Tiedekirja (annual turnover about 330 000 euros)
- Logistics central and storage for learned publications (about 200 000 books and journals)
- International exchange centre for scientific literature (based on UNESCO convention)
- Policy work nationally and internationally
- And today's specialty: Journal.fi and Edition.fi


Finnish scholarly publishing landscape



Kotilava project (2015-2017)

- Journal.fi is a result of the Kotilava project
 - The National Library of Finland & the Federation of Finnish Learned Societies
- Kotilava project aimed to make the Finnish academic journals open in a sustainable way and to guarantee that their articles have a wide visibility and impact = make journals flip to OA
- Two subprojects:
 - 1) **The tech**: the development of a platform for cutting down the cost of publishing
 - Budget ca. 115 000 euros, mainly for development work
 - 2) The money: funding model for Finnish OA journals

Starting point: Scientific Journals Online



Four areas of development

Appearance

- New brand: site name, logo, domain name
- Responsive and better looking layouts

Technical infrastructure

 Support for central OA standards like DOI, ORCID, DOAJ, CC etc. and also national services

Journal.fi

Maintenance

- Written agreements with journals
- Internal documentation for maintenance, updates and technical support
- Finnish instructions for OJS 3.0

System development

- Upgrading to OJS 3.0
- New Finnish translation for OJS
- Solving reported system deficiencies and bugs
- Creating new features to OJS

Journal.fi (https://journal.fi)

- Test upgrades from OJS2 in late 2016, OJS 3 Workshops for journals
- Launched in January 2017
- Mostly small journals with limited resources, published by member learned societies
- Not officially a national platform
- Based on Open Journal Systems 3 (https://pkp.sfu.ca/)
- Both a platform for publishing journal articles and a tool for editorial work
 - around 30-40% of journals use the editorial workflow
- Hosted on our own server

How many journals in Journal.fi?




- "Natural growth", a clear need for a publishing platform
- ca. 120 Diamond OA journals (no APCs)
- ca. 20 with embargo

Journal.fi: criteria for acceptance

- Publisher has to be Finnish or at least major co-operation with Finnish organisation has to take place
- For member societies:
 - Open, but one year embargo allowed
 - Journal may use only the editorial workflow and publish elsewhere
 - All journals published by member society accepted
- Other publishers
 - Immediately open, no embargo allowed
 - Only peer reviewed journals
- Signed contracts with journals/publishers
- Service is free for member societies, a nominal price for others (about 200 e / year)

Journal.fi: support

- Our support includes:
 - A shared platform and system upgrades
 - Coding services (has to benefit all journals)
 - Online technical support (mostly OJS questions)
 - OJS Workshops for new editors
 - Written guides
- Staff: 1,5-1,7
 - One full time, three employees partly involved in technical support, OJS workshops, management of agreements and server maintenance
 - Platform budget is part of the IT department budget at the Federation
- Actively contributing to the OJS core and maintaining some key plugins for the system available for all OJS users
 - Important part of using an open source software is being a part of the community!
 - Long-term support: making sure the software thrives



Survey of Journal.fi -users

Role	Users	Share
Student	266	40 %
Researcher	240	36 %
Private citizen	52	8 %
Other expert	49	7 %
Teacher	35	5 %
Journalist	9	1 %
Civil servant	7	1 %
Entrepreneur	8	1 %
Politician	2	0 %
All users	668	100 %

- Just before library lockdowns
- The two largest groups were students (40%) and researchers (36%), followed by private citizens (8%), other experts (7%) and teachers (5%).
- Other identified user roles include journalists, civil servants, entrepreneurs and politicians.

Openjournals

Introduction

- Dutch diamond open access platform for scholarly journals
- Launched in 2021, https://openjournals.nl
- Currently 26 journals, adding one new journal every month
- Mainly in humanities and social sciences, but also medical
- For university press, professional organisations, health organisations, independent editorial boards



Openjournals

How it started:

- Project proposal from OA advocates to NWO (Dutch Research Council)
- Develop a DOA platform for journals, particularly in humanities/social sciences
- Platform is infrastructure, journals remain independent
- Part of a wider discussion on Open Science in the Netherlands: NPOS2030
- Seed funding provided by NWO (Dutch Research Council) 2020-2023
- Additional funding from journals and universities



Openjournals: Organisation, governance, reporting

Organisation, governance, reporting

- Now
 - Small project team (project manager, functional support, communication), 1.3 FTE
 - IT support (30-40 hours/month)
 - Steering committee, reporting to NWO
 - Based at research institute ("Huygens Institute")
- Preparing new structure:
 - Management team
 - Supervisory Board representing all large stakeholders/financers
 - User board
- But who is ultimate owner of openjournals?
- Future owner/organisation/governance/funding



Openjournals: Standards

Standards

- Participating journals are DOAJ registered or work towards registration.
- Diamond open access model
- Agreements with journals in place, also defining/defining open access, licenses, copyright, archiving
- We advise on other indexing services.
- Eager to assist journals in raising standards and/or modernise journals
- Some journals contain more than scientific papers, also have society news



Openjournals: Business Model

Business model

- Openjournals financed by:
 - NWO (Dutch Research Council), through 2 grants, covering ~50-60% costs
 - Some universities provide more support, as part of their own Open Science ambitions
 - Journals (boards, society, university) pay annual fee (now € 3,000)
- Now developing sustainable model, based on shared interest of stakeholders
- Costs openjournals:
 - 1.5 2 fte plus IT support, about € 200k/year (including overhead)
- Costs to journals:
 - Annual fee to openjournals, typesetting, editorial assistance, design, communication





Openjournals: Platform and Costs

Platform

- PKP-OJS software (open source software), maintained by local team (~30-40 hours/month)
- PKP-OJS software used by over 30,000 journals worldwide, large community, also large platforms
- Two parts: (1) editorial workflow (2) publication
- No copyediting and typesetting (outside system)



Openjournals: Engagement

Engagement

- Website with news items, newsletters, social media
- Active outreach to connect to new journals
- Interact with main stakeholders (universities, libraries, funders)
- Users day
- National open science events
- Clear position in NPOS2030 plans



Openjournals: Future

Future

- New funding secured for 2023-2028, for implementing growth plan:
 - 1. More journals (growing to 80 journals in 2027)
 - 2. More functionality (existing and participate in development)
 - 3. More services (editorial support, promotion, industry standards)
 - 4. More collaboration (among journals, internationally)
 - 5. More outreach (to wider audience)



Openjournals: Lessons Learnt

Lessons learnt

- Useful to work with OJS, with large community, active forum, well documented
- Manage expectations of editors/journals, be prepared to guide editors/journals
- Long-term plan



The "Dutch Journal of Applied Linguistics" has been accepted for registration by the "Directory of Open Access Journals" (https://doaj.org). DOAJ's mission is to increase the visibility, accessibility, reputation, usage and impact of quality, peer-reviewed, open access scholarly research journals. DOAJ registration is regarded as an important and widely accepted quality stamp and therefore this (future) registration is a requirement for journals hosted on openjournals. The DOAJ website contains a detailed list of criteria for inclusion of journals.


