1. What we need

3. What we do with it

Your personal data is processed in The Royal Irish Academy located in Ireland. Hosting and storage of your data takes place in Office 365, Admincontrol, JotForm, AWS and on Academy file servers which are in the EEA.

Your data will be accessed by the Communications and Programmes and Administration departments and it will be shared securely with the appropriate team members of the American Chamber of Commerce, Ireland.

The data supplied is used to:

- Generate a unique access link for your online application form
- Share an application pack for your nominated award category
- Issue an invitation to you to participate in a 'Preparing your application' webinar on Thursday, 2 December at 10am.
- Contact you in autumn 2022 with details of the call for applications for the 2023 US-Ireland Research Innovation Awards.

Your data will not be repurposed for any other objective and no other third-party providers have access to your data, unless specifically required by law.

4. How long we keep it

We will retain data supplied when registering an expression of interest for these awards until October 2022, when all contact details will be securely deleted. The remaining information is retained for reporting purposes (internally and externally, including the American Chamber of Commerce, Ireland). This can include returns on gender, award category interest and name of the interested corporate entity. These data are anonymised for reporting purposes. This information may be retained indefinitely for archival and research purposes.

5. What are your rights?

Should you believe that any personal data we hold on you is incorrect or incomplete, you have the right to request to see this information, rectify it or have it deleted. You have also the right to know what of your personal data we are processing (right of access).
